#### **Answer**

The Sales Tennis is made up of subscriptions, junior tennis income, match fees, pay and play income, and tennis ball sales

The Sales other is made up of a council grant, furlough, and the club lottery

Cost of sales tennis, comprises of court maintenance, juniors' costs, LTA subscriptions, and tennis ball purchases

The cost of sales other was the pool table

#### Club Captain Report – Graham Brown

#### Captain's Report

This had already been circulated to the members on 20th May 2022, The following questions had been received:.

#### **Club Captains Report Questions and Answers**

#### Question

**Junior Tennis** 

My grandson is a junior member of the Hamilton. I am rather upset that Libby Duncan has felt she has had to resign her position due to lack of support and belief in her presence in the club and made to feel the way she did.

My question is why did she not receive the support from our Tennis Committee? She was introduced to the club by an ex-member who was temporary captain at the time of the club. Yes, she did report to the Chairman but when speaking to Libby she said that this was the only way she would stay at the club because she was not made to feel welcome by certain tennis members.

My next question is where do our established junior members go?

You say in your report that this gives you the opportunity to review and consider an approach to be looked at but there does not seem to me anything concrete. Libby gave her

notice in a few weeks ago and I would like to think that you have started a programme for them. Why was there no handover with Libby to keep these up-and-coming members Forgive me if I am wrong, I will watch with bated breath and hope that Junior tennis is given the priority it deserves.

Other than the email from the club sending out Libby's resignation we have heard nothing positive about trying to keep the junior members here and feel they have just been left high and dry. Why did the Tennis Committee not join in with the tennis sessions knowing Libby was leaving and give them a plan and encourage them to stay at the Hamilton. Plus they have paid a full years membership; I know this is not expensive but surely they have a right to some sort of tennis activities. I feel they have been disregarded as members of this club.

#### **Answer**

Graham responded by saying that the chairman had continually told the TC not to get involved with the Juniors.

The chairman responded that initially this was true, but the TC had shown no interest in the juniors. Comments were made from members that the TC should have shown interest.

#### Question

Why hasn't the TC made sure there is integration between the head and junior coach?

#### **Answer**

Graham answered this by first pointing out that we do not have a head coach, 1 to 1 and group team coaching is only provided by Richard Physick. Then reiterated that the chairman had continually told the TC not to get involved with the Juniors.

This response did not go down well with the AGM attendees.

#### Question

Why didn't the TC respond and support the LTA "She rallies" initiative as opposed to leaving it all to Libby?

#### **Answer**

There was no real answer, but the chairman pointed out when he received the information from the LTA it was sent to the TC with a copy to Libby and Libby was the only person that responded, with no help from the TC.

#### The chair invited any other questions

A question was asked why the telephone and internet was so high, the answer was it included the BT Sports and the website costs (which is £50 per month)

#### **Constitution Proposed Amendments**

The chairman made the following comment:

"It is very interesting that the proposals have all come from members of the TC and they are clearly aimed at 3 people here today"

The Management Committee reserves the right to increase or decrease at any time, the number of its Management Committee and to designate a title or role to a member of the Management Committee performing a specific duty.

Any Full Member (5.4.2) is entitled to attend any Management or Sub Committee Meeting as Observers. They cannot contribute to the proceedings and they have no vote.

Members with unspent criminal convictions or cautions are not permitted to be a member of the Management Committee. All applicants will be required to declare any unspent convictions or cautions.

## **Management Committee – Gordon Hughes**

The chair started this by making the following statement:

"We have seen the split in our club has festered over the last few years which has been aggravated by the TC in the last year

It is beginning to destroy this club

It is my opinion the only way forward is to deal with this situation once and for all and make sure the club, both tennis and social members are all pulling together for the good of our club.

To sort this, it could be painful as I believe we need to ask certain members to either change their ways or consider their future with our club.

I now invite members to make their views known today as it may determine how we as a club move forward"

There then followed a discussion about having two committees and how certain members clearly did not support a "one club! Ethos" and that the disrupted factions had always been within the club.

It was pointed out by previous chairpersons that it always used to be one committee which removes communications issues between two committees

It was overwhelming agreed that we should act and move forward as a "one club" and that we should only have one committee, to action this a proposal would need to be put together and an EGM called for any agreement as this is a change to the constitution.

B Farnsworth made a statement about how the existing Chairman had navigated the club successfully through a difficult time keeping the club financially secure and safe, he then proposed that Gordon Hughes should remain as the chairman, which was agreed by a majority show of hands.

So Gordon remains as the chairman and Dee will remain as the secretary,

#### **AOB**

The following questions had been submitted:

#### Topic 1

Please can you explain why the TC has gone back to using its unofficial email rather than the official Hamilton email address for tennis queries.

"I understand the 'tennismatters' email should not be used as it is against HLTC GDPR policy. I have been a tennis player here for many years and would like my emails to come through the official route. I have been sent their email but I did not give my permission for them to use it. It says on it that I can opt out but if I do then I won't be able to receive tennis information. Also, with them using this email it does not automatically go to everyone so it is therefore not inclusive to all.

Why do the TC need to do this? It is causing a lot of contention"

Graham Brown answered that by saying that the TC had decided that they wanted to provide information regarding tennis activities to the tennis member without any changes or propaganda.

This was rejected as an answer and it was pointed out that in the last year only two suggested communication were not followed through, of which the MC members knew about, one referring to the lottery which attempted to turn members away from participating and the other was a email from the club captain about team training, which referred to the tennismatter banned email, which he was asked to change, but never did.

It was pointed out that this question had come from a tennis member, so clearly the correct process should be used.

The chair reminded the members that the group emails are generated from the membership database which hold all the members details and access to this is strictly controlled as it is key to the club's GDPR policy.

#### Topic 2

"Where are the email addresses stored?"

Will Harrison answered this by stating they are stored in the "cloud" like the club ones are, the chairman responded that the member's emails are stored on the club's computer, not the "cloud"

One tennis member then stated that they were only interested in receiving tennis emails and that the Hamilton official email were put into their junk, the response was swift stating that this clearly did not align to a one club attitude.

There then followed a general discussion about the volume of emails, with suggestion about a possible newsletter or increased usage of the website, it was pointed out the newsletter would still need to be distributed via email and that not all members refer to the website.

#### Welcome

The Chairman thanked members for attending and pointed out that the only topic was as detailed on the agenda, namely, the management committee re-structure and the change to the tennis committee statement as issued in the proposal to the members

#### The debates

The chairman invited those present to make any comments, but firstly read out the following statement:

"I remind all members of the various discussions at the AGM where most of the attendees agreed that there should only be one committee to ensure the club moves forward as "one club"

Yes, the concept is that the MC would manage all parts of the club and I can assure tennis members that the tennis element is key on the MC agenda

As I have already stated we have to move forward with a one club ethos and having the one committee is fundamental in achieving this.

I am a strong believer that members would stand up to help the club in any way they can without being confined to a committee.

The main advantages of the one committee

• Removes conflict between 2 committees

- Clarifies the communication processes
- Ensures compliance to club policies and procedures
- Supports the one club ethos
- Clearly puts the onus on the MC and the members are clear about their involvement
- Can only blame the MC for any failures

Possible main disadvantage is that there would be additional work and responsibility placed on the MC members

Based on this I would urge members to vote in favour of the proposal submitted"

There then followed various point for and against the proposals

#### **The Voting**

The proposals were clarified as to what was being voted on, the restructure of the management committee and effectively the dissolving of the Tennis Committee, so there would only be the Management committee.

The result of the vote was:

- Attended 52 members
- 35 were in favour of the proposals (this represents 67% of those attended)
- 11 rejected the proposal and
- The balance abstained

Therefore, the proposals were accepted

The meeting ended at 20:06

## 2023 AGM Chairman's Report. 2022-2023

The year saw a revision to the Management Committee, resulting from the Tennis Committee being disbanded. The revised Management Committee was modified to incorporate a Tennis Co-Ordinator, (Will Harrison took this role). This change has provided a total focus on all the club's activities by the Management Committee. The Committee comprised of myself as the Chairman, Edwin as the Vice Chair, Alison as the Treasurer, Dee as the Secretary, Initially Richard as the Club Captain, which was the taken on by Gillian following the sad death of Richard, Matt as the Social Representative and of course Will as stated above.

And we appreciate Lesley has continued to manage our financial books. Sarah Jones our Welfare Office continues to attend the Management meeting to keep the focus on safeguarding.

With regards to tennis coaching, there was various movement within the year.

We saw our junior members decline when Libby decided to leave our club and join the R2R organisation.

Richard Physick, the main coach, departed, at our request, and we set up a tennis coaching contract with R2R who supports various clubs The initial R2R coaching got off to a challenging start but now is getting on track.

The "Pay and Play" continues, and to date we have taken over £3k since it started. It is great to see some of the social members are taking advantage of this.

It is good to see that we are still a preferred venue for various function, which is the key to our survival. Some success includes, quiz nights, pie night which was in aid of LOROS (our designated Club Charity for 2023 and 2024) The club social programme has now kicked in, with a focus on our centenary year, which again provides additional revenue for us.

During the year it was good to see some members come forth for the creation of the Funding and Marketing teams, who are working hard and beginning to make a difference.

We continue to manage our website, trying to keep astride of the changing requirements; if anyone has forgotten their password to access the members area, please ask.

The club lottery continues to be successful, with 110 tickets sold. The lottery team worked hard to sell these tickets.

In summary over the past year, we have:

- Consolidated the club management into one committee, the Management Committee
- Created the Funding and Marketing teams.
- Replace the top court backboard.
- Professionally cleaned the bottom courts.
- Restarted the social programme, to celebrate our 100<sup>th</sup> year.
- Updated/refreshed our website.
- Reviewed and increased the venue hire prices.
- Updated the venue hire conditions.
- Can create and manage our own posters etc, to maximise our marketing options.

The audited net financial result for the year end (end of March 2023) is that we are showing a loss of £137, which is an improvement on the previous year. A positive, is that we remained in a positive cash flow situation, which, at our year end was, £17.1k in the bank and £18k in the building society. The financial details are shown in the Treasurers report.

As at the financial year ends the membership stood at:

The biggest decline is in the Tennis membership, generally related to injuries, house moves, members moving to other tennis clubs and the change to the tennis coaching. The R2R focus is to help increasing our membership and are now includes a level 4 coach in addition to Libby Duncan who is now a level 3 should help.

As our members are aware the recent Open Day resulted in 11 new members at a "one day only special price" which is a good start.

The main objective for the coming year is to maximise our revenue through our membership, revenue from social events and venue bookings. Having a good revenue and controlling costs would give us a continuous opportunity to address some of the facilities improvements. To aid this the non-membership room hire have been significantly increased, and we are looking at food options and prices.

Over the coming year, subject to funds, we plan to undertake the following:

- Re-paint the bottom courts (now done)
- Focus on increasing all types of the memberships.
- Focus on ways that would increase the financial income.
- Create access to the bottom courts via Hartland Road, for maintenance purposes.
- Continue to establish a way that disability tennis could be adopted on the bottom courts.
- Investigate potential ways to improve the appearance and functionality of the club house, with the initial focus of improving the front view of the building.

# 2023 AGM Treasurer's Report. 2022-2023

As the Chairman's report states the audited figure shows a nett loss for the year of £137

The attached accounts represent the official audited status for the year ending 31st March 2023.

In terms of the turnover figure, we achieved an improved over the previous year, although it is not back to the figures prior to the pandemic.

As already stated, the cash flow has been challenging but we have remained in the black throughout the year, without transferring any funds from the building society account to support the bank transactions.

Generally, the costs shown the normal trend that we would expect, the good news is that despite the sales being greater than the previous year, the costs are lower as shown in the details.

We continue to monitor the Profit/Loss using the 3 cost centres, being: Clubhouse, Tennis, and General Overheads. As agreed by the Management Committee, the general overheads are split 70%/30% Clubhouse/Tennis. The result of this is that the Clubhouse shows a profit of £1180, and the Tennis shows a loss of £1317. A copy of this is attached, for the members information, bearing in mind this report is not part of the audited accounts and shows a slight difference in the total loss (-£139 as opposed to -£137 on the audited accounts)

As you can see from the accounts the book value (Fixed assets) of the club as at 31<sup>st</sup> March 2023 is at £245,959
